Gentlemen,

We were all sworn in at the Freedom of Information hearing April 23rd in Hartford #FIC 2014-631, which after 90+/- minutes was continued to June 3, 2015 in the hope that by opening all the Stony Creek Association records my complaint might be withdrawn. This request is a continuation of that hearing:

Since that meeting, I have been in contact with Mr. Lee and it is my understanding that he is in the process of reviewing the language on the affidavit he agreed (at the hearing) to give stating that the Stony Creek Association has no records or files documenting real or estimated damages to the parties named in the appeals.

For review, on or about June 20, 2014 Dan and Tim signed a retainer agreement making the Stony Creek Association a client of Mr. Lee's law firm, which agreed to represent the SCA in the matter of "Opposition to Expansion of the Legacy Theatre."

Please produce:

- (1) Copies of all records or files - prepared, owned, used, received or retained, whether handwritten, typed, tape-recorded, photostated, photographed, or recorded by any other method - of real or estimated damages to any and/or all members of the Stony Creek Association as a result of the Legacy Theatre's "Tenant Fit Up" application and/or the decision by the Zoning Board of Appeals of the Town of Branford.
- (2) Copies of all records or files - prepared, owned, used, received or retained, whether handwritten, typed, tape-recorded, photostated, photographed, or recorded by any other method - of real or estimated damages to any person living in Stony Creek as a result of the Legacy Theatre's "Tenant Fit Up" application and/or the decision by the Zoning Board of Appeals of the Town of Branford.
- (3) Copies of records or files of all SCA payments made to Tim Lee (and/or his law firm) from the beginning of his service on or about June 20, 2014 to the present.


(4) Copies of all records or files of funds donated to the Stony Creek Association expressly for the purpose of paying Mr. Lee's legal fees.

(5) Copies of all records or files of funds donated to the Stony Creek Association, which the Stony Creek Association can use for the purpose of paying Mr. Lee's legal fees.

If there are any questions regarding this request, Mr. Lee may call me at 203-485-2132, leave a message, and I will return his call. All phone conversations are for clarification only. Mr. Lee is an attorney and as stated in my written argument put into evidence at the FOI hearing I am a seventy-five year old concerned citizen with no legal training.

There are other records I would like to inspect, so if you would like me to review the above requested records before making copies of them that would be agreeable with me. I will be by Mr. Bullard's office during business hours (9-5) most likely on Tuesdays and Thursdays. If Mr. Lee would like to be present we can arrange a convenient time. Please inform me when the above requested records will be available for inspection.
