Police & Traffic:

- According to Sgt. Watrous, there was 1 report of speeding on Thimble Island Rd. this month.
- Sam Kirby pointed out that there are crosswalks in other parts of town that do not lead to sidewalks, why can't we do in Stony Creek?
- Police are happy to come to the meeting if there are issues to discuss other than speeding or stopping at crosswalks.
- Public Comment:
 - Suggestion from Linda Reed to consider raised crosswalks to reduce speeding.

Maintenance:

- Sandy Fischer, committee chair, reported that there is a deep hole under the underpass again. She encourages residents to call Tom Brennan at Public Works about this issue (203) 481-4156.
- Dan Bullard reported he called Pam and Tom about the electrical outlet at the triangle and they had someone fix within 48 hours.
- Sandy Fischer encourages residents to clean any drains they have on or near their property.
- Ed Gagliardi reported that the state cleaned the street on Leetes Island Road and put new signage up for the crosswalk.

Administration:

• Mark Richter, committee chair, reported that he has attempted to discuss the Charter Revision idea with Sean Scanlon, he is waiting to hear back.

New Business:

- Medlyn's Farm: Stony Creek Association is not taking a position on this. Pete DaRos gave a brief history.
- Legacy Theater:
 - Jim Strub and Caleb are still working on the Memorandum of Understanding between the individual plaintiffs and Legacy Theater. Once the MOU has been drafted and approved by all parties, then it is presented to the Judge and the court will issue a stipulated judgement.
 - It is our understanding that a stipulated judgement would bypass the town RTM and police department.
 - Some board members feel that it is unacceptable that there is no agreement yet.
 - o It is our understanding that the December 19th deadline will be pushed back if judge sees reasonable progress. Tim Lee has asked for a continuance.
 - o Dan Bullard offered to go to Town Hall to get a progress report from Aniscovich or Cosgrove.
 - Special meeting scheduled for Tuesday December 13th at 1pm at the Willoughby Wallace Memorial Library to review the MOU.
- Would like to discuss the Parks in Stony Creek at the next meeting. Still work to be done on Gazebo, tables to be added to Bayview Park, etc.
 - Parks Commission: would like to consider for Stony Creek so Stony Creek Parks could be included in the Branford Budget.
- Looking to revise the charter to bring it up to the 21st century. Also, Board is authorized to tax up to 5 mills, this should be looked at.

Motion made by Jim Walker, seconded by Sam Kirby and approved to adjourn the meeting at 9:03pm.
