Minutes of the Stony Creek Association – Executive Board Meeting July 13, 2021

Call to order: A meeting of the Stony Creek Association Executive Board was called to order at 7:00 p.m. on Tuesday July 13, 2021, via Zoom by Mark Richter.

Minutes: A motion was made by Hanna Purdy, seconded by Harlan Fritzenhold and unanimously approved to accept the minutes as written from the 6/8/2021.

Treasurer's report

- Greg Ames reported that the month began with \$29,382.12. One bill was paid for \$104. There is \$30,341.18 in certificates of deposit for total \$59619.30 to begin on July 1st. Going forward, the new treasurer Brian Love will take over the reporting.
- There was a motion to accept the treasurers report for audit by Amy Bloom and seconded by Ellen Page. All were in favor.
- The following bills were presented: Wayne Jacobson for 15 days of clean up for \$600, Greg Ames \$19.14 for printing, liability policy premium \$4,609, Mark Richter 853.24 printing, for postage for the election \$407, Jake Greenvall for dog poop bags \$150.47, Inc lawncare \$205. Total bills to be paid is \$6844.11.
- Motion to approve paying the bills as presented was made by Hannah Purdy and seconded by Emma Barnes. All were in favor.

• Hannah Purdy made a motion seconded by Emma Barnes to approve the treasurer to pay the election workers up to the budgeted amount previously approved when they send the invoice in. All were in favor. Thank you to our election workers!

Tax collector's report:

- Nick Fischer reported that there is only one person who has not paid their taxes.
- Harlan Fritzenhold made a motion to extend the due date of the tax bills to be one month past the existing due date as established by the tax collector. Amy Bloom seconded and all were in favor.

Legal & Zoning

• Ted Ells wrote up a summary of the Legal and Zoning committee and included details on what the committee does.

Police and traffic

- Steve Palumbo Jr. reported that signage at School St. and Watrous Ave were illegal because they are on telephone poles. The crosswalk needs to be repainted because it has faded. Crosswalks at the beach need more space on either side before the parking spots for better visibility. This has been approved by the police commission.
- Normally signs to watch for pedestrians crossing are up at the beach crosswalk and towards trolley trail crosswalk but have not been put up yet. This is most likely due to the water authority work. Steve Palumbo Jr. will follow up on getthing those signs put up.
- REMINDER: Remember to lock your cars and remove your keys. There have been breaking into cars in Stony Creek as well as a car stolen this month in Stony Creek.

Maintenance

- Susan Torre brought up issue of overgrowth on the corner of School St. and Thimble Island Rd
 which hides the speed limit sign. Tanya Greenvall reported that walking up Leetes Island Rd the
 sidewalk has overgrowth which forces walkers to step into the street.
- Alison Bromage reported that they put new recycle bins out around town. One bin is at Bayview Park, one at the beach and another at Madiera Park. Hannah Purdy will reach out to Gary Zelinski (head of public works in Branford) to find out if public works will handle the overgrowth on Leetes Island Rd.
- Emma Barnes will talk to Rob at Stony Creek Pizza to see if they could take back their pizza boxes so that the pizza boxes don't fill up the garbage cans.

Charter Review Committee

Harlan Fritzenhold reported that the committee has been working fo the past 2 years to update the
Charter for the Stony Creek Association. They are now working on edits to the language in the
Charter. They hope to have a document to present to the association for a vote in the next month
or two. After that they will work on revising the By-Laws of the Association so they match the
Charter.

Maintenance Committee Stony Creek Association Executive Board 2020-2021

The Maintenance Committee of the Stony Creek Association (SCA) Executive Board tracks the Town of Branford's maintenance of SC public roads, docks, parks, sidewalks, signage, and public trash receptacles. This also includes tracking upkeep on and replacement of playground equipment, fences, retaining walls and seawalls, trash cans, fountains, flag poles, and planted spaces. It also covers traffic line painting for flow and parking, seasonal crosswalk signs, lifeguards for the beach, and street sweeping.

The Committee serves as the SCA's voice to the Town of Branford government, which is ultimately responsible for the aforementioned maintenance. Because Stony Creek is one of numerous neighborhoods that together constitute the Town, the town officials often depend on SCA communications to know what specific maintenance is currently required. Our advocacy helps ensure that work is scheduled and executed in a timely and acceptable fashion.

LEGAL AND ZONING C2OMMITTEE

The Legal and Zoning Committee is responsible for advising the Association on any legal issue involving the community. It also keeps the community informed of planning and zoning issues in Stony Creek which come before the Branford Planning and Zoning Commission, Branford Zoning Board of Appeals, Inland Wetlands Commission and Stony Creek Architectural Review Board.

DULTIES OF COMMITTEE

- 1. Chairperson should introduce her or himself to the Town Planner, Assistant Town Planner, Zoning Enforcement Officer and Planning and Zoning secretary at Town Hall.
- Chair or someone on Committee should subscribe on line to minutes of Planning and Zoning Commission and should check agendas and minutes of Planning and Zoning, Zoning Board of Appeals, Inland Wetlands and Stony Creek Architectural Review Board on Town website.
- 3. Chair or someone on committee should go to Town Hall the day of or day before Stony Creek Association meeting and look at all applications or matters in Stony Creek on Planning and zoning, Zoning Board of Appeals, Inland Wetlands and Stony Creek Architectural Review Board and look at each file, making copies if needed.
- 4. At Stony Creek Association Executive Board meetings, the Chair should report on the status of all planning and zoning applications affecting Stony Creek. If appropriate, the Committee can recommend that the board take action with respect to an application.
- 5. The committee should be familiar with the zoning regulations of the town of Branford, the U.S. Department of the Interior National Register designation of the Stony Creek and Thimble Islands and Historic District, the Stony Creek Village District Guidelines and the Stony Creek Architectural Review Board.
- 6. The Chair or member of the committee should attend any hearing upon an issue the committee is considering recommending that the board take action.
- 7. Other minutes and agendas to check: Demolition applications and demolition delays, building permits.
- 8. Committee should familiarize themselves with Branford Town ordinances and be able to obtain information on any legal questions which may arise.
- 9. Committee should be knowledgeable concerning the Freedom of Information Action laws and regulations that may affect the Association.
- 10. Committee should be knowledgeable as to the Charter and By-Laws of the Association and make recommendations as to revisions and amendments needed from time to time.
- 11. Committee Chair or member should attend seminars offered from time to time for Branford town officials.
